Battery Energy Storage System Safety

With the passage of the Bipartisan Infrastructure Law and the Inflation Reduction Act, as well as the falling costs of renewables, battery energy storage systems are becoming a more attractive generation and capacity source for many utilities. The benefits and challenges of commissioning these types of systems are becoming clearer, specifically around the area of safety. As part of the Rural Energy Storage Deployment Program (RESDP), NRECA Research worked with DOE's Pacific Northwest National Laboratory to provide an overview of the codes and standards for stationary battery energy storage systems and some considerations for cooperatives as they deploy this technology.

Implementing Fundamental Cybersecurity Measures

NRECA's Co-op Cyber Goals program provides a variety of ways for cooperatives to advance their cybersecurity posture and establish fundamental cybersecurity measures. Ten Level One goals were announced in 2023, and we recently announced an additional 10 goals as Level Two. Over 425 co-ops are now participating in the Cyber Goals Program. Most experts agree that the U.S. grid will need thousands of miles of new and upgraded transmission in order to meet skyrocketing electricity demand and connect new generation sources while ensuring that power remains reliable and affordable. The ability to site and build this critical infrastructure, however, is being weighed down by supply chain bottlenecks and clouded by new federal regulations that could lead to a more rigid, less equitable planning, permitting and cost-allocation process, among other challenges.
