2024 National Directors Survey Results

Every other year, NRECA conducts the National Directors Survey (NDS)—a comprehensive survey of system policies and practices pertaining to cooperative governance. The NDS provides benchmark data regarding board compensation, along with board practices and policies. The survey results also include a brief section on services provided that are not “traditional” electric transmission, generation or distribution efforts, including broadband. Co-ops who participated in the survey may purchase the results for \$295. Co-ops who did not participate may purchase the results for \$995, which includes an executive summary.
