#### The Cyber Mutual Assistance (CMA) Program

The CMA Program is a trusted community of utilities, including electric cooperatives, that share information, conduct exercises, and help each other. All electric cooperatives regardless of size are eligible to join the CMA Program. There is no cost to join. Participation is voluntary and at your discretion, and confidential information is protected by a mutual non-disclosure agreement (NDA). NRECA encourages cooperatives to consider joining the CMA Program to help enable Cooperation Among Cooperatives and improve preparation and response to cybersecurity threats to utilities.

# **Distribution Automation Tool Survey – Deadline March 25**

NRECA has started a Distribution Automation (DA) initiative that aims to develop a variety of resources that can be used by co-ops to create a DA strategy and process based on grid needs and co-op goals; evaluate DA technologies and plan for increased adoption; and implement DA and operate the grid in a safe, secure, and cost-effective manner. As a part of this initiative, we are developing a DA benefit-cost analysis tool that will analyze the revenue requirements over the expected life of a co-op investment to determine if the benefits achieved outweigh the total cost of ownership. Co-ops are invited to participate in a survey by March 25 to provide input into the development of this tool.

## **How Co-ops Use Federal Funding to Help Their Members**

In our most recent RE Magazine issue, NRECA looks at how some co-ops throughout the country are using the influx of federal dollars to benefit their members.
