PARALEGAL MEMBERSHIP ELIGIBILITY AND TERMS:

An ECBA paralegal member must be sponsored by a current ECBA member in good standing who certifies the applicant: (1) is employed by or with an ECBA member, or by NRECA or an NRECA Voting Member; and (2) provides paralegal services related to one or more NRECA Voting Members. An ECBA paralegal member's membership is terminated automatically upon the sponsoring ECBA member ceasing to be an ECBA member, unless another ECBA member in good standing sponsors and certifies for the paralegal member. ECBA paralegal members are nonvoting members and may not hold an office or vote in elections. Further, they have read-only privileges for the ECBA discussion listserv. All other ECBA member benefits, including website access, apply to ECBA paralegal members.
