On October 1, as part of National Cybersecurity Awareness Month, the American Public Power Association (APPA), Edison Electric Institute (EEI) and National Rural Electric Cooperative Association (NRECA) will hold a briefing for Congressional staff on electric sector cybersecurity.

Join us to hear from experts on what the electric power sector and our government partners are doing to ensure reliable and resilient electricity for the nation. Among the issues to be discussed will be the role of the industry-government and cross sector coordination, the Electricity Subsector Coordinating Council and the "all-hazards" approach to grid security. We will also hear from Karen Evans, the Assistant Secretary for Cybersecurity, Energy, Security, and Emergency Response (CESER), on the role of her new office.

Speakers will include representatives from the federal government, the electric sector and the North American Electric Reliability Corporation (NERC).
