# **Broadband Availability Challenge Communication Toolkit**



VCP is encouraging consumer-members to review and challenge broadband availability information shown on the Federal Communications Commission's new broadband maps, and we need your help to secure funding for co-op communities.

Why does it matter? \$42.5 billion has been allocated to bring broadband to areas that lack high-speed coverage. If the FCC maps use inaccurate data, people who do not have access to quality internet will not get the services they need.

**How can you help?** To ensure we engage members, we are asking co-ops to share content with their members highlighting this national effort. The deadline for challenges is Jan. 13, so we need your help to get the word out fast.

What's next? Included in this toolkit are sample social media posts, talking points for questions and a flyer to share in your lobby.



## **Talking Points**

Below is a sample converstation between a member and co-op employee. You can these talking points to help answer any questions or concerns you may encounter from members.

**Member:** I've seen this organization called Voices for Cooperative Power running Facebook ads. Do they represent our co-op?

**Co-op Employee:**Yes! Voices for Cooperative Power is the national advocacy campaign representing the interests of electric cooperatives and the communities they call home. They work with co-ops to ensure their voices are heard on important policies at the local, state and federal level.

**Member:** I see they're trying to challenge some kind of broadband maps. What is that about?

**Co-op Employee:** The Federal Communications Commission, who oversees the broadband deployment, recently released maps outlining which households do and do not have internet services available to them. Unfortunately, these maps are drastically inaccurate, meaning some homes – which could include yours – appear to have access to internet, but the reality is much different. These maps are important because they will be used to determine future funding for broadband projects.

Member: Oh wow, how can I help make sure the maps are correct?

**Co-op Employee:** VCP is encouraging members to visit the FCC's website, review the internet providers listed at their address and file a challenge if any of the information is incorrect.
